



LA OFICINA EN COLOMBIA DEL ALTO COMISIONADO DE LAS NACIONES UNIDAS PARA LOS DERECHOS HUMANOS ANUNCIA EL NOMBRAMIENTO DE CHRISTIAN SALAZAR VOLKMANN COMO REPRESENTANTE DE LA ALTA COMISIONADA EN COLOMBIA

(Bogotá, 2 de marzo de 2009)

La Oficina del Alto Comisionado de las Naciones Unidas para los Derechos Humanos, cuya sede se encuentra en Ginebra, anuncia el nombramiento del Sr. Christian Salazar Volkmann, de nacionalidad alemana, como su nuevo representante en Colombia. El Sr. Salazar Volkmann fue seleccionado mediante el proceso de reclutamiento competitivo regular de las Naciones Unidas y tomará funciones en la Oficina en Colombia este 2 de marzo de 2009.

El Sr. Salazar Volkmann aporta a esta posición su probado compromiso con el trabajo de derechos humanos, a través de su labor en Guatemala, Vietnam e Irán, así como su sólida trayectoria en coordinación interinstitucional, programación y gerencia.

El Sr. Salazar Volkmann, ha trabajado con UNICEF y la Sociedad Alemana para la Cooperación Técnica GTZ. Consistentemente ha apoyado los derechos de las y los niños, así como la prevención de ejecuciones juveniles. El Sr. Salazar ha investigado, extensamente aplicado y capacitado en la inclusión de la perspectiva de derechos humanos en programas.

En Guatemala, prestó asistencia técnica a la Oficina de Derechos Humanos de la Arquidiócesis de Guatemala, a la Comisión para el Esclarecimiento Histórico y a la Corte Interamericana de Derechos Humanos en temas de violaciones de los derechos de las y los niños, en nombre de UNICEF y GTZ. Asimismo, fue responsable de una variedad de programas relacionados con la construcción de paz, educación de paz, reformas legales y alianzas de los defensores de derechos de las y los niños.

El Sr. Salazar Volkman es Maestro en Ciencias de la Comunicación, Filosofía y Economía y Doctor en Ciencias Políticas. Cuenta con una gran cantidad de publicaciones, en diferentes idiomas, sobre temas de justicia juvenil, política social, equidad, gobernabilidad, derechos humanos y sociedad civil y ha coordinado una gran cantidad de reportes temáticos sobre los derechos de las y los niños. En publicaciones recientes, promueve el diálogo intercultural sobre derechos de las y los niños, de las mujeres y aborda temas de justicia juvenil en el Islam.

El Sr. Salazar Volkman, de 47 años, está casado y tiene cuatro hijos.



UN HIGH COMMISSIONER FOR HUMAN RIGHTS ANNOUNCES THE APPOINTMENT OF CHRISTIAN SALAZAR VOLKMANN AS THE HIGH COMMISSIONER'S REPRESENTATIVE IN COLOMBIA

BOGOTÁ — The Office of the High Commissioner for Human Rights, which is based in Geneva, announces the appointment of Mr. Christian Salazar Volkmann, a German citizen, as his Representative in Colombia. Mr. Salazar Volkmann was selected through the standard United Nations recruitment process and will start functions on 2 March 2009.

Mr. Salazar Volkmann brings to this position proven commitment to the work of human rights, through his work in Guatemala, Vietnam and Iran, as well as strong skills in interagency coordination, programming and management.

Mr. Salazar Volkmann has worked with UNICEF and the German Society for Technical Cooperation GTZ. He has consistently supported the rights of the child and the prevention of juvenile executions and has researched, extensively applied, and trained on human rights based approach to programming.

In Guatemala, he provided technical advice to the Human Rights Office of the Archdioceses of Guatemala, to the Truth Commissions of Guatemala and to the Inter-American Court for Human Rights on gross violations of children's rights on behalf of UNICEF and GTZ. Furthermore he was responsible for a variety of programmes related to peace building, peace education, legal reform and alliances of child rights defenders.

Mr. Salazar Volkmann holds a masters' degree in communication sciences, philosophy and economics as well as a PhD in political sciences. He has published extensively, in several languages, on issues related to juvenile justice, social policy, equity, governance, human rights and civil society and coordinated the elaboration of numerous thematic reports on children's rights. In recent publications, he promotes intercultural dialogue on child rights, women's rights and juvenile justice in Islam.

Mr. Salazar Volkmann, 47 years old, is married and has four children.
